Sarah Eckhardt's Experience

Andy Brown's Experience

Presides over the Commissioners Court

- Served 6.5 years on the Commissioners Court as Precinct 2 Commissioner

- Spoke at Commissioners Court two times, providing citizen communication on SH-45 and vote centers
- Presided over monthly meetings with volunteer Democratic precinct chairs

Sets the county's annual budget

- Negotiated 6 annual balanced budgets during her time on the court, up to \$814 million dollars
- Set the overall budget for all county departments and 48 elected officials

- Oversaw \$500,000 annual budget for the Travis County Democratic Party

Sets budget for civil and criminal county and district courts and jails

- Served 8 years as a prosecutor for the County Attorney
- Secured protective orders for family violence victims as a Texas Rio Grande Legal Aid attorney
- Supported creation of the Mental Health Public Defender's Office
- Supported expanded public defender services, including the Mental Health Public Defender's Office
- Supported specialized courts to reduce repeat offenses for DWI, public intoxication, drug use, and family violence

- Worked as a civil attorney in private practice for 10 years
- Briefly represented 1 person in criminal court but then passed him to another attorney

Builds and maintains county roads

- Chosen as Vice-Chair of Capital Area Metropolitan Planning Organization (CAMPO) by elected officials from 5 Central Texas counties
- Wrote, passed, and defended Toll Road covenants at CAMPO to protect toll rate payers and secure more funding for transit and bike/ped improvements
- Advocated for local-option transportation funding at the Texas Legislature
- Voted to concentrate transportation funding to support existing communities instead of promoting further sprawl

- Served on the 2010 City of Austin Transportation Bond Oversight Committee

Protects natural resources, establishes parks and green spaces

- Negotiated \$3.5 million settlement from developers for fouling Hamilton Pool
- Implemented new stringent county water quality and stormwater regulations
- Prevented destructive use of the Balcones Canyonland Preserve
- Spearheaded the County's recently passed zero-waste initiative

- Donor to a large number of environmental organizations

Establishes the tax rate and exemptions, negotiates all tax rebates on behalf of the county

- Consistently opposed corporate tax giveaways, including \$20 million to Formula 1
- Advocated for transparent and performance-based budgeting and contract awards to achieve the best and most cost-effective government services
- Reduced property taxes for senior citizens and the disabled
- Adjusted the historic exemption to protect heritage homes without eroding our tax base
- Overhauled the economic development policy to focus on job creation for those most in need of opportunity

- No discernible tax policy experience
- Has not stated a clear position with regard to tax rebates and incentives, or if he would oppose future tax giveaways to Formula 1
